


Who We Are

What We Do



The situation has gone from bad to worse in the region. The demand for second homes increased substantially during 2020-2021 and increased prices to levels that are untouchable for most of the local workforce.








Policy Priorities

- Lay the foundation for the creation of affordable homes for all and housing equity serving all residents of the North Lake Tahoe Truckee community
- Increase access to a wide range of housing types–from Accessory Dwelling Units, to Single Family Residential, to small scale and/or Multi-family housing
- Focus attention on two top priorities–Affordable Housing at <80% AMI and Achievable Housing between 80% AMI & 195% AMI
- Reduce homelessness by supporting the creation of housing and housing-related services for the homeless community
- Retain existing affordable and achievable housing, including existing affordable housing and affordable- by- design housing, such as secondary units and mobile home parks
- Advance and encourage a rational planning, zoning and permitting environment with broad-based support from local jurisdictions that are implementing those policies to exceed Regional Housing Needs Allocation targets
